

#GoForMore54 Sweepstakes
Official Rules

1. SWEEPSTAKES PERIOD:

The "#GoForMore54 Sweepstakes" (the "**Sweepstakes**") begins on Thursday, January 16, 2020 at 12:00:01 a.m. Eastern Time ("**ET**") and ends on Sunday, February 2, 2020 at 11:59:59 p.m. ET (the "**Sweepstakes Period**"). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible for the drawing. Sponsor's/Administrator's database clock will be the official time-keeping device for this Sweepstakes.

2. ELIGIBILITY:

The Sweepstakes is open only to individuals who are legal residents of the fifty (50) United States and the District of Columbia (i.e., excluding Guam, Puerto Rico and all other U.S. commonwealths, territories and possessions), who are eighteen (18) years of age or older (or age of majority in their state of residence, whichever is older), and who reside therein at the time of entry (each an "**Entrant**"). Employees, officers, directors and contractors of BankUnited, N.A. ("Sponsor"), Administrator (defined below), Republica Havas, LLC, Twitter, the NFL Entities, and each of their respective parent companies, affiliate companies, subsidiaries, agents, professional advisors, directors, officers, shareholders, and employees, distributors, retailers, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, webmasters, and any all other companies associated with the Sweepstakes,

immediate family members (spouses, parents, children, siblings, grandparents, grandchildren, and step children, wherever they may live) and/or those living in the same household, whether or not related, of each (collectively, "Sweepstakes Entities") are not eligible to participate or win a prize. Proof of residency and age may be required. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. **This Sweepstakes is void outside of the fifty (50) United States and the District of Columbia, and where prohibited or restricted by law or regulation.**

3. AGREEMENT TO OFFICIAL RULES

Entrant must enter the Sweepstakes from within the fifty (50) United States or the District of Columbia only. Submissions originating from any other jurisdiction are not eligible for entry and will be disqualified. - Entrant is responsible for ensuring that their Twitter account is set to "public", and for taking any further necessary steps to ensure receipt of any communications from Sponsor/Administrator. To Enter via Online Entry Form:

- To enter the Sweepstakes without having to submit an entry via Twitter, during the Sweepstakes Period go to www.GoForMore54.com to access the Online Entry Form for the Sweepstakes. By successfully transmitting a completed Online Entry Form as directed, including any hashtag, question or other required information, Entrant will receive one (1) entry in the random drawing. Entrants must fully complete and submit all non-optional data requested on the Online Entry Form to be eligible for entry into the random drawing. Incomplete and/or inaccurate entries are void. All entries via the Online Entry Form must include a valid email address for the Entrant. Entrants to the Sweepstakes via the Online Entry Form may be given the option to receive commercial emails and/or mobile text messages and updates from Sponsor; however, eligibility to participate in the Sweepstakes is not dependent upon Entrant's consent to receive such emails and/or mobile text messages, and updates and consenting to receive such emails and/or mobile text messages and updates will not impact any Entrant's chances of winning. 5. ADDITIONAL ENTRY CRITERIA

Proof of submission of a tweet or online entry form does not constitute proof of delivery. All entries will become property of the Sponsor and will not be returned to the Entrant. Every entry must be manually keystroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including, without limitation, entries made using any script, macro, bot, or game service) is prohibited and any entry through such means will be disqualified, and transmissions from these or related phone numbers or IP addresses may be blocked. Once any entry is submitted, Entrant cannot access/revise such entry in any way. All Entries become the property of Sponsor and will not be returned.

Any attempt by an Entrant to use multiple Twitter usernames, email addresses, identities, registrations, logins or phone number to enter the Sweepstakes will invalidate ALL entries submitted by that Entrant for the entire Sweepstakes Period. The Sweepstakes Entities assume no responsibility for lost, late, misdirected, incomplete, damaged, inaccurate or undelivered tweets, online entry forms, answers, emails, or direct messages, or for any computer, online, telephone or technical malfunctions or interruptions in service that may occur for any reason.

In the event of a dispute about the identity of the Entrant, entries will be declared made by the authorized account holder associated with the account on which the entry is submitted, provided such individual is eligible according to these Official Rules. The "authorized account holder" is

defined as the natural person who, for entries via Twitter, is assigned to a Twitter account by Twitter, and for entries via the Online Entry Form, the applicable internet service provider or other organization responsible for assigning addresses has assigned the email address for the domain associated with the submitted email address. A potential winner may be required to provide proof that he/she is the authorized account holder of the account associated with the winning entry.

Failure to follow any instructions provided, or failure to submit any entry within the Sweepstakes Period or in compliance with these Official Rules, may result in disqualification.

6. SUBMISSION GUIDELINES AND RESTRICTIONS

- Submission content must be Entrant's original creation and be owned 100% by Entrant, or alternatively, Entrant must have the full right to grant the license and other rights granted to Sponsor in these Official Rules.
- Submission text must be in English.
- Submissions must not contain content that is untruthful, incomplete, inaccurate, false, or misleading.
- Submission must not tag or refer to (or include in any image, photo or video) any individual under the legal age of majority without providing a signed release from the parent or legal guardian.
- Submissions must not, in Sponsor's/Administrator's sole discretion, violate or infringe any third intellectual property rights including, but not limited to, copyright, trademark, trade dress or other proprietary rights of any entity or person (living or deceased) including, but not limited to, the right of privacy, publicity or portrayal in a false light.
- Submissions must not make reference to any commercial/corporate advertising including, without limitation, corporate logos, brand names, or slogans (other than Sponsor's).
- Submission must not include any commercial solicitation or promotional materials, or website addresses.
- Submission must not include any personally-identifiable information (e.g. first or last name, address, phone number, place of work, email address, etc.).
- Submissions must not contain, as determined by the Sponsor/Administrator in its sole discretion, any material or content that:
 - I. is sexually explicit, obscene, pornographic, lewd or indecent, or depicts suggestive behavior or nudity;
 - II. defames, misrepresents, or contains any disparaging, derogatory, libelous, or slanderous remarks about Sponsor, Administrator, the Sweepstakes Entities, or other people, products or companies, or their respective products and services;
 - III. includes threats or violence to any person, place, business or group;
 - IV. includes explicit language or content;
 - V. promotes gambling or other illegal activities;
 - VI. promotes bigotry, racism, hatred, or harm against any group or individual, or promotes discrimination based on race, sex, gender, religion, nationality,

- disability, sexual orientation, age or any other basis protected by federal, state or local law, rule or regulation;
- VII. promotes alcohol, tobacco, e-cigarettes, illegal drugs, or firearms/weapons of any kind including, without limitation, guns, knives, bombs, grenades or other projectiles (or how to assemble or use of any of the foregoing);
 - VIII. promotes any activities that may appear unsafe or dangerous;
 - IX. promotes terrorist activities;
 - X. promotes any particular political agenda or message;
 - XI. promotes any religious beliefs;
 - XII. includes offensive messages, or endorses any form of hate or hate group;
 - XIII. is a duplication of any other submission;
 - XIV. is unlawful, or otherwise in violation of, or contrary to, any federal, state or local laws, rules or regulations; or
 - XV. includes any language communicating messages inconsistent with the positive images and/or good will to which Sponsor wishes to associate.

Any submission that in Sponsor's/Administrator's sole discretion does not comply with the foregoing, or is deemed to be inappropriate or unsuitable, will be disqualified.

7. SELECTION OF WINNER

If a 2-point conversion is successfully completed during the big football game on February 2, 2020, one (1) potential prize winner will be selected by random drawing from among all eligible entries received during the Sweepstakes Period. The random drawing is scheduled to take place approximately five (5) business days after the Sweepstakes Period end date listed above. The random drawing will be conducted by COHEN-FRIEDBERG ASSOCIATES, LLC, 17 Lantern Road, Suite 101, Framingham, MA 01702 www.cfapromo.com, an independent judging organization, (the "Administrator"), whose decisions shall be final on all matters relating to this Sweepstakes. The odds of winning depend on the number of eligible entries received during the Sweepstakes Period and whether a 2-point conversion is successfully completed. If a 2-point conversion is not successfully completed, or if the big game does not take place as scheduled for any reason, there will be no winner, and at Sponsor's sole discretion, the prize may be donated to a charity or charities of Sponsor's choice.

8. WINNER NOTIFICATION

The potential winner will be contacted via direct message on Twitter, or by email, depending on entry method, within approximately one (1) business day of the drawing. The potential winner must respond within two (2) calendar days from the time of notification, and provide his/her name, address, age, and other personal information necessary to receive the prize. Sponsor/Administrator is not responsible if a prize notification is lost, intercepted or not received by any potential winner for any reason including, without limitation, if the potential winner's wireless or online service has been suspended or discontinued, or for any change in a potential winner's email address or Twitter account.

To the fullest extent permitted by applicable law, the potential winner will be required to complete, sign, have notarized, and return an Affidavit of Eligibility and Liability/Publicity Release, and appropriate tax documents, and present a valid government issued photo identification and social security number (collectively, "Documents") within seven (7) calendar days of the time specified by Administrator in order to claim his/her prize. If (i) the attempted prize notification is returned as undeliverable, or the potential winner does not respond within two (2) calendar days of notification by Administrator; or (ii) any Documents are not executed, presented, or returned within seven (7) calendar days of the time specified by Administrator; or (iii) the potential winner is otherwise unable to accept the prize as stated, the prize will be forfeited in its entirety and, at Sponsor's/Administrator's sole discretion, an alternate potential winner may be selected by random drawing from all remaining eligible entries. The potential winner is subject to verification by Sponsor/Administrator, whose decisions are final and binding in all matters related to this Sweepstakes. 9. PRIZE

There is one (1) prize. Prize consists exclusively of \$54,000 (awarded in the form of a check made payable to the winner). The prize will be awarded and/or delivered only to addresses within the United States. Checks may take up to ninety (90) days to be issued and mailed to the winner. The approximate retail value ("ARV") of the prize is \$54,000. In no event will more than the stated number of prizes be awarded.

Prize is non-transferable, non-assignable, non-exchangeable and no substitutions will be permitted. Sponsor/ Administrator will not replace any lost, misplaced, mutilated, or stolen prize.

All applicable federal, state and local taxes (including income and withholding taxes), and any other costs and fees associated with prize acceptance are the sole responsibility of the winner. The winner will receive an IRS Form-1099 from Sponsor reflecting the final actual value of the prize after the end of the calendar year in which the prize is awarded, and a copy of such form will be filed with the Internal Revenue Service ("IRS").

10. PUBLICITY RELEASE

By entering the Sweepstakes, each Entrant grants to Sponsor/Administrator and the Sweepstakes Entities, his/her express permission to use his/her name, photograph, likeness, voice, image, avatar, testimonial, statement, biographical information, and city and state of residence, at any time or times, for advertising, trade, publicity, and promotional purposes in any media now known, or hereafter devised, worldwide, in perpetuity, without limitation and without further compensation, consideration, permission or notification, unless prohibited by law.

By participating in the Sweepstakes, Entrant hereby acknowledges and agrees to the collection and usage of his/her personal information in accordance with Sponsor's privacy policies.

12. PUBLICATION, LICENSE AND RELEASE

If the Sweepstakes is terminated, canceled or suspended, Sponsor may, at its sole discretion, select the winner and award the prize by way of random drawing from all non-suspect, eligible entries received as of the date of the event giving rise to such termination, cancellation or suspension. Inclusion in such drawing shall be each Entrant's sole and exclusive remedy under such circumstances.

Sponsor shall not be liable to any Entrant, winner, or any other person for failure to supply the prize or any part thereof by reason of any acts of God, any actions, regulations, orders, or requests by any governmental entity, equipment failure, terrorist acts, war, fire, unusually severe weather, embargo, labor dispute or strike, labor or material shortage, transportation interruption of any kind, or any other cause beyond Sponsor's control.

Under no circumstances will Entrant be permitted to obtain awards for, and hereby waives all rights to claim, lost profits, and/or punitive, incidental, indirect, special, and consequential damages, and any other damages including, without limitation, attorney's fees, other than for actual out-of-pocket expenses (e.g. costs associated with participating in this Sweepstakes), and Entrant further waives all rights to have damages multiplied or increased. In any event, the maximum aggregate liability of Sponsor to any person directly or indirectly relating to this Sweepstakes or the prize shall not exceed the sum of \$10.00.
